

**THE WINNING  
OPTION  
CONTEST**

**The contest runs from January 24, 2025, at 9:00 a.m., to February 20, 2025, at 11:59 p.m. (EST). All times referenced in these rules refer to Eastern Standard Time (EST).**

1. The contest sponsor is Guardian/I.D.A./Remedy'sRx pharmacies, a division of McKesson Canada (hereinafter the "Sponsor" or "Guardian/I.D.A./Remedy'sRx") and the prize provider is McKesson Canada (hereinafter the "Prize Supplier").
2. This contest is only open to residents of Canada who have reached the age of majority, with the exception of employees, representatives and agents of the Sponsor and the Prize Supplier, or their respective affiliated companies (including employees of the Sponsor and the Prize Supplier and all Guardian/I.D.A./Remedy'sRx pharmacies and, where applicable, their respective advertising and promotion agencies, contest judges (where applicable), other contest prize suppliers, any other enterprise involved in the development, production or distribution of materials for this contest, and the immediate family members of the above-mentioned persons or persons residing with one of the above-mentioned persons.

**A. **A1. Purchase for additional chance.** Simply purchase one (1) Option+ product at a participating Guardian/I.D.A./Remedy'sRx pharmacy during the event, between January 24, 2025, at 9:00 a.m., to February 20, 2025, at 11:59 p.m. The purchase of one (1) Option+ product gives you one (1) additional chance to win, by completing all mandatory fields on the online participation form in the "Contest" section of the [www.guardian-ida-remedysrx.ca](http://www.guardian-ida-remedysrx.ca) website (hereinafter, the "Record of Participation"), and by also completing the math question within the time allotted, during the contest period, from January 24, 2025, at 9:00 a.m., to February 20, 2025, at 11:59 p.m. Registrations that do not include the valid receipt number of the transactions, the date of participation, along with the Guardian/I.D.A./Remedy'sRx pharmacy number will automatically be rejected. Limit of one additional chance per person (valid email) with an Option+ product purchase. This action is not mandatory to participate in this contest but allows an additional chance to win.

4. This contest begins on January 24, 2025, at 9:00 a.m., and ends on February 20, 2025, at 11:59 p.m. The draw will be held on Monday, March 3, 2025, at 2:00 p.m. at the CRI agence. The winners will be contacted by email and must meet the eligibility criteria specified in paragraph 8 below. The winners' names will also be posted on Guardian/I.D.A./Remedy'sRx [www.guardian-ida-remedysrx.ca](http://www.guardian-ida-remedysrx.ca) website.
5. The odds that a participant's Record of Participation is selected at random depend on the number of records of participation registered and received in accordance with paragraph 3 above.
